# Privacy policy

This page describes site management procedures with reference to the processing of the personal data of its users.

This website contains information regarding clinical research trials sponsored by Zambon S.p.A., therefore some of its contents are intended for healthcare professionals only.

## DATA CONTROLLER

Data Controller of your personal data is Zambon S.p.A., a company located in Italy, with registered office in Bresso (Milan), via Lillo Del Duca 10 – 20091 (hereinafter “Zambon” or the “Controller”). For the purposes described in this Policy, the Controller may utilize services of external providers, which have been duly appointed as Data Processor pursuant to art. 28 GDPR and will process your personal data following Zambon’s instructions.

## PERSONAL DATA COLLECTED AND PROCESSED

The website is accessible to users without the need to provide any personal data; nevertheless, we may collect some information about you, when you visit our website and when you interact with some of the functionalities of the website.

### Browsing Data

Computer systems and software programs designed for navigating this website acquire, during their normal use, certain personal data, whose transmission is implicit in the use of Internet communication protocols. This category of data includes IP addresses or domain names of computers used by users who visit the website, URI (Uniform Resource Identifier), request times, methods used to send requests to the server, the size of files received in response, numeric codes indicating the status of the server's response (e.g., successful, error) and other parameters related to the user's operating system and computer environment.

Such data, which is deleted immediately after processing, is used by the Company for the sole purpose of collecting anonymous statistical information on the use of the site and to monitor its correct functioning.

It may be used to ascertain responsibility in the event of Internet violations which threaten to damage the site: notwithstanding this outcome, all data on web contacts shall expire within seven days.

## **Clinical Site Locator**

If you wish to do so, you may anonymously (without the need to provide any personal data or any other information which may lead to your identification as a user) use the website to locate the centers where the BOSTON-1 and BOSTON-2 studies are being carried out. If you wish to do so, you will have to enable the geo localization setting of your browser or device (e.g., computer, smartphone, tablet) when accessing the website to locate the study center nearest to your location. You can manage directly your localization choices from your device; also, you can modify your choices at any time, by turning off (also, temporarily) the localization services on your device. In any case, we do not retain information regarding the actual geographic location of our users.

Please note that this functionality is addressed to healthcare professionals only.

## **PURPOSES OF THE PROCESSING**

Zambon will process your personal data, as described in the previous paragraph for the following purposes:

- collecting information on the use of the website (e.g., how much time users spend on web pages; how users navigate through the website), monitor its correct functioning and help diagnose technical and service problems;
- managing, operating, evaluating and improving our website and business (including enhancing and improving our services, managing our communications, performing data analytics, and other internal functions);
- protecting against, identifying and preventing fraud and other criminal activity, claims and other liabilities; ascertaining responsibility in the event of Internet violations which threaten to damage the website;
- complying with and enforcing applicable legal requirements, relevant industry standards and our policies.

## **COOKIES**

When you visit our website, we may collect certain information by automated means, such as cookies. A cookie is a small text file that websites send to a visitor's computer or other Internet-connected device, to uniquely identify the visitor's browser or to store information or settings in the browser. The function of the cookies is to streamline web traffic analysis or indicate when a specific website or part of a website is visited, and to distinguish between visitors in order to provide personalized content. Cookies help administrators improve the website and the users'
